Introduction

Information you provide to us

Personal Information

- When beginning to use our services, we will generally collect personal information from you, such as, but not exclusive to, your first and last name, e-mail address, as well as your username and password information when you create an account to log in to our services (“Account”).
- In order to fulfill transactions, we will collect payment information necessary to for the completion of these transactions, which include, but are not exclusive to, your name, credit card information, and billing information.
- If you provide us with any form of feedback or other form of contact using email, we will retain your name and email address, as well as the information and content included in the email, enabling us to reply to your message.

Information we collect via technology

Log Files & Traffic Data

When you access and use Hexient Services, we log information about you including your Internet Protocol (“IP”) address, referring/exit pages, data/time stamps, and clickstream data access times, browser type and language, Internet Service Provider (“ISP”), and the Web pages that you visit (collectively “Visitor Information”). The Website may utilize this information to aggregate traffic data about the various groups of visitors who use the website at any one point in time (collectively “Traffic Information”). The collection of this

3rd Party Tracking

Assessment Terms

Hexient Assessments (“Assessments”) are provided by Hexient via an online web application designed to assess important skills for job selection purposes. Use of assessments is determined by Employers (the “Employer”) and who assessments are sent to, the Candidates (the “Candidate”), is determined by Employers.

In order to take an Assessment, Candidates may be required to create a temporary login and password. Account information you submit with Hexient falls under the same provisions of the

Privacy Policy and Terms of Service on our website. Employers will use the Hexient application to enter in Candidate information, distribute Assessments, and gain access to individual assessment results.

Employers and Candidates acknowledge that the Assessments provided by Hexient are designed to assess a very specific set of skills that do not encompass the entirety of knowledge, skills and abilities required to do a job. Whether a particular skill and/or assessment is relevant for the job being applied for is decided solely by the Employer sending the Assessment.

Hexient is not responsible for offering alternative methods of screening, if so required by the Americans with Disabilities Act or any other equivalent state act, this responsibility falls under the discretion of the Employer sending the Assessment. If any Candidate requires accommodation, they can indicate this to the Employer to provide.

Candidates receiving or responding to an Assessment delivered by an Employer does not guarantee a job or job offer, or any other responsibilities (i.e. communications, salary levels, responses, interviews) by the Employer.

Employers agree to having Candidate consent before sending an assessment to them.

Hexient does not guarantee that any Candidate will receive, access, read or respond to any Assessment, or that there will be no mistakes in the transmission of the data. However, Employers may be notified if such events do occur.

Employers agree that the Employer has made the determination to use Assessments provided by Hexient as one method of screening in their application process, and the Assessments serve as relevant to the job they are hiring for. Employers agree that they are solely responsible for the use of Assessments and responses in compliance with the law.

Hexient reserves the right to change any Assessment or the questions asked within an Assessment at any time for any or no reason.

Hexient assumes no responsibility and disclaims all liability in regards to the content, accuracy, validity, completeness, legality, reliability, or availability of the Assessments

Candidates agree that by taking an Assessment provided by Hexient that any and all information provided via the Assessment may be used to influence an Employers selection decisions. An Employer is the sole party to determine whether a Candidate is qualified for the

position they are applying for or not, regardless of what the Hexient Assessment results indicate.

Employers agree that Hexient retains no responsibility in regards to selection decisions and/or Candidate communications

Employers and Candidates agree that you shall not access or use Assessments provided by Hexient for any directly or indirectly illegal, discriminatory, threatening, abusive, fraudulent, or otherwise objectionable purposes.

Hexient is not a third party to or liable for any agreements between an Employer and Candidate.

Employers agree to keep all information gleaned from the Hexient application confidential, only to be used by employees within your organization, namely the Human Resources department and those in charge of selection decisions related to the Assessment.

EEOC

The Design and Development of Hexient Assessments (“Assessments”) is rooted in I/O psychology and decades of hiring research. The Assessments have been designed with reference to the Equal Employment Opportunity Commission (EEOC) and the Uniform Guidelines on Employee Selection Procedures (UGESP). Hexient has taken great effort in attempting to help companies mitigate any bias and discriminatory behavior in assessments, including measures to attempt compliance with the Equal Employment Opportunity Act of 1972, Title I of the Americans with Disabilities Act (ADA), and The Age Discrimination in Employment Act (ADEA).

Hexient takes great measure in using a standardized process in the development of Assessment content. This includes various forms of compliance with the above doctrines, such as job analysis, identification of KSAOs, and leveraging Subject Matter Experts. Job Analysis information was primarily gleaned from the US government database of US jobs (ONET). Through this job analysis, Hexient is able to better determine the KSAOs that are deemed to be important for success in a particular role. Hexient also engages subject matter experts in the roles for which the Assessments have been designed to be applied to.

As mentioned above, Hexient puts great effort in assuring quality of assessments and compliance with doctrines and guidelines such as the Uniform Guidelines. As part of this effort, for each Assessment that Hexient creates, we take great measure in attempting to establish Assessment validity, reliability, and fairness. This helps Us verify the quality, effectiveness, and

reliability of Assessment. This is done through industry best practices in I/O psychology to determine Content Validity (SMEs determine the extent to which an item is relevant to the job and skills in question), Criterion Validity (Assessment performance is compared to existing performance measures), Reliability, and various dimensions of Fairness.

Hexient will also undergo vigorous testing to assure product quality and mitigate against any unwanted affects resulting from assessment completion, such as discriminatory results in areas such as gender, race, age, and others. If any group differences are found during our analysis, assessment content will be redesigned and retested so it can be adjusted and Fairness can be assured.

Test Administration is up to the sole discretion of Employers who are customers of Hexient and are using the Hexient application. However, Hexient does recommend to Employers/Customers various best practices to ensure fair test administration, such as, but not excluded to, creating a standardized testing experience. The Assessments themselves have been developed to assure standardization across assessment takers, including standard instructions, questions, pre established time limits.

As Hexient is continually in the process of improving assessment quality, Employers recognize that each assessment may not accurately represent the applicant's actual level of competency in the respective skill areas Hexient purports to assess. Hexient Assessments have not yet been validated using a larger population of test takers, although we are in the process of doing this and continuously improving assessment quality. Companies who use Assessments provided by Hexient and are Hexient customers are fully and solely responsible for ensuring adherence to the EEOC guidelines and other applicable employment law to mitigate risk against any form of discrimination or negative hiring outcomes. Companies are also responsible for offering other forms of screening and candidate evaluation aside from Hexient Assessments, and agree that Hexient Assessments measure a specific set of skills that do not cover the entirety of job skills required for success in that role. The Employer is fully and solely responsible for Candidate accommodation in regards to compliance with the Americans with Disabilities Act or any equivalent. The Employer agrees to indemnify Hexient for any and all claims arising out of an Employer's use of a Screening Tool, including any claims that any screening tool does not comply with any form of Employment law or the above doctrines and guidelines stated.

Company's are responsible for determining the appropriateness of the assessment instrument for the job in the selection process, understanding the scope of the assessment effectiveness, and using the assessment in accordance with relevant EEOC recommendations and Employment law.
